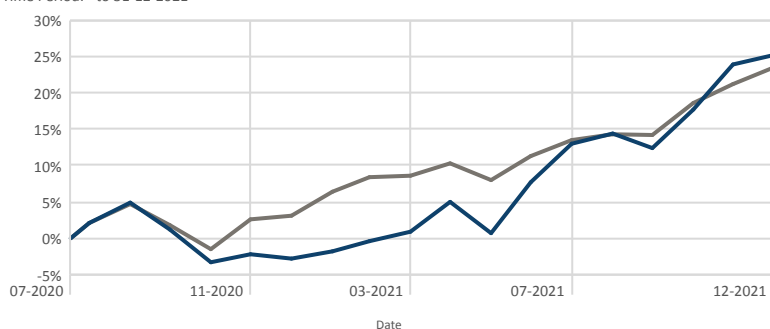
The Cratos BCI Worldwide Flexible Fund seeks to sustain a high long-term total return.

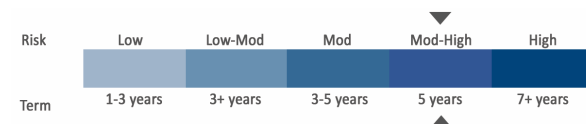

### Moderate - High Risk
